Admission requirements: Any national, foreign and stateless candidate who holds a doctorate degree in the area of management or in science/engineering/technology and a scientific and professional curriculum whose profile is suited for the activity to be performed can submit their applications. If the doctorate has been awarded by a foreign higher education institution, it must comply with the provisions of Decree-Law no. 66/2018, of August 16, and any formalities established therein must be complied with.

Admission requirements for the position are:

- PhD in area of management or in science/engineering/technology;
- Knowledge/experience in biomedical sciences;
- Experience in the management of international collaborative projects, such as FP7 or H2020;
- Proficiency in English, written and spoken.

Work plan: The successful candidate will perform tasks related to the project management and dissemination activities:

- Preparation and writing of deliverables according to the project plan,
- o Enable timely reporting to the European Commission,
- o Guarantee efficient communication with European Commission,
- Provide regular update on project management actions,
- Support project meetings organization,
- o Set clear communication and dissemination actions and guarantee their implementation,
- Support the project exploitation activities,
- Support the MOBILISE ERA CHAIR grant holder and Management Committee in all aspects related to the project management.

Evaluation criteria:

The evaluation of the CV of the candidates, namely the scientific merit and management capacity in science and technology, will be made according to the following criteria:

a) Detailed CV (55 %)

-List of publications relevant to the area to which they apply (10%)

- R & D & D projects in which they participate or participated (15%)

- Experience in R & D + D with relevance to the i3S, namely in the area of international projects (30%)

b) Declaration of motivation for the area where the application is placed as well as a detailed description of the action plan that intends to develop during the duration of the contract (15%).

c) To provide further clarification, candidates that fulfil the admission requirements will be interviewed (30%).

Candidates final classification shall be given based on a scale 0-100.

Contract duration: 12 months, with possibility to be renewed up to 24 months. The contract is expected to start in February 2021.

Value for monthly salary: Salary will be indexed to Single Salary Table ("Tabela Remuneração Única" - TRU), **level 50 to 54** of the TRU (equivalent to assistant researcher), according to candidate experience. The Portuguese Labor Law will regulate the contract. The selected candidate will benefit from an excellent research environment.

Applications are open from the 8 to 24 January 2021.

a) Detailed curriculum vitae in English;

b) Copy of certificates or diplomas;

The present tender is exclusively destined to fill the specify vacancy and can be terminated at any time until approval of final candidate list, expiring with the respective occupation of said vacancy.
